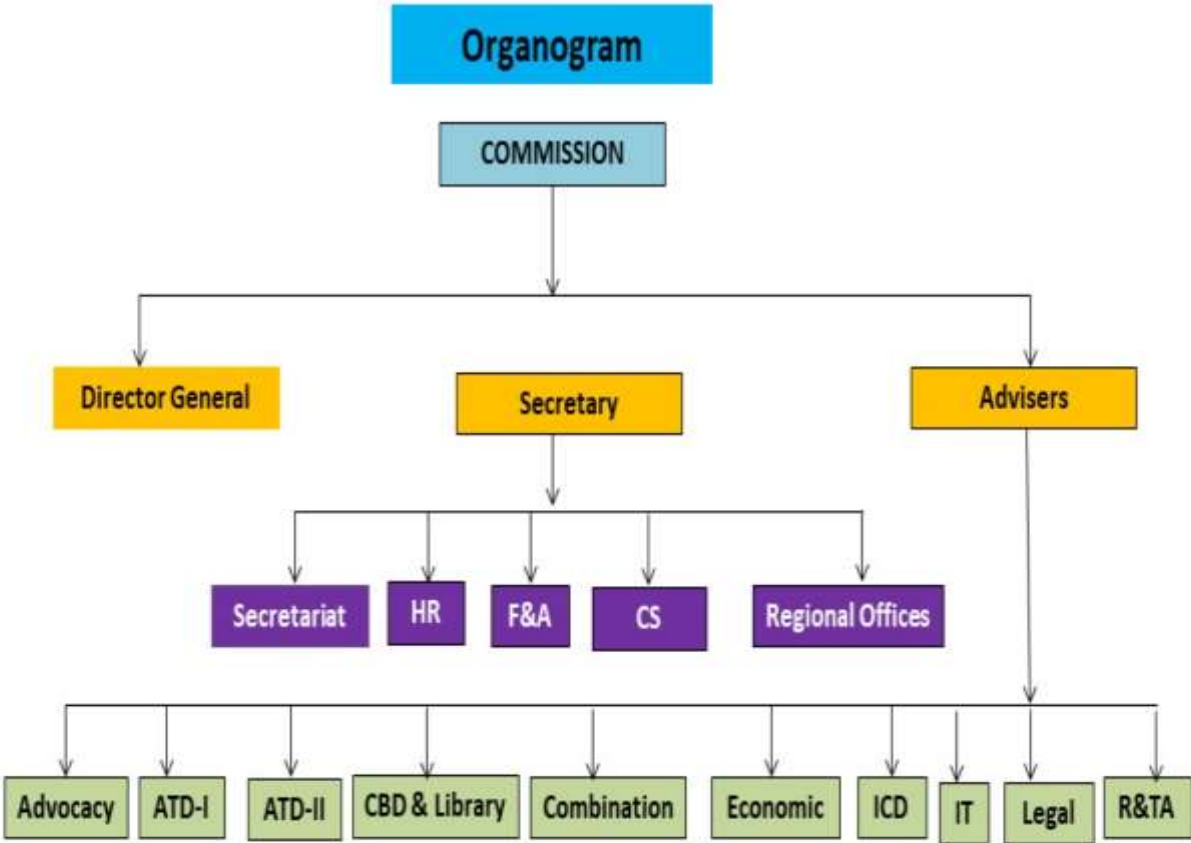

The Competition Act, 2002 (No.12 of 2003)(Act) was enacted with the objective to prevent practices having adverse effect on competition, to promote and sustain competition in markets, to protect the interests of consumers and to ensure freedom of trade carried on by other participants in markets, in India, and for matters connected therewith or incidental thereto. The objectives of the Act are sought to be achieved through institutional set up of Competition Commission of India (CCI) (the Commission) which has been established by the Central Government with effect from 14th October 2003 vide S.O.1198 (E) dated 14.10.2003. The Competition Act was comprehensively amended by the Competition (Amendment) Act, 2007. Thereafter, it was amended in 2009 & 2017. The Commission was duly constituted on March 1, 2009. The Commission consists of a Chairperson and 2-6 Members appointed by the Central Government. The Chairperson has the powers of general superintendence, direction and control in respect of all administrative matters of the Commission.
